PARK RULES AND REGULATIONS

- **DOGS MUST BE ON A LEASH NO LONGER THAN 6 FEET. PLEASE DISPOSE OF DOG WASTE.** County Ord. 41.123
- **SMOKING, INCLUDING VAPING AND ELECTRONIC CIGARETTES, IS PROHIBITED.** County Ord. 41.118.5
- **NO CAMPING OR FULLY ENCLOSABLE TENTS.** County Ord. 41.150
- **ALCOHOL IS NOT ALLOWED WITHOUT AN EVENT PERMIT.** County Ord. 41.139
- **SHOPPING CARTS, TROLLEY/CARTS, LUGGAGE CARRIERS, OR EXCESSIVE AMOUNTS OF PERSONAL PROPERTY ARE NOT ALLOWED.** County Ord. 41.105, 41.106
- **USE OF MOTORIZED AND NON-MOTORIZED BICYCLES, SCOOTERS, SKATEBOARDS, IN-LINE SKATES OR OTHER SIMILAR WHEELED DEVICES IS NOT PERMITTED.** County Ord. 41.130
- **BIKES MUST BE STORED AND SECURED IN PROVIDED RACKS.**
- **NO ORGANIZED SPORTS, PRACTICES, GAMES, CLASSES, OR PRIVATE TRAINING UNLESS APPROVED BY THE COUNTY.** County Ord. 41.124
- **OBJECTS, SUCH AS HAMMOCKS, SIGNS, PIÑATAS, DECORATIONS, WORKOUT EQUIPMENT, AND DOG LEASHES CANNOT BE ATTACHED TO PARK PROPERTY INCLUDING TREES, BENCHES, EQUIPMENT, FENCES, RAILS, ETC. UNLESS SIGNED OTHERWISE.**
- **NO GLASS BOTTLES OR CONTAINERS.** County Ord. 41.141
- **NO COMMERCIAL TRANSACTIONS, SELLING, VENDING, OR ADVERTISING, WITHOUT A PERMIT.** County Ord. 41.136.
- **NO APPLICATION OF SIDEWALK CHALK OR ANY OTHER COLORED SUBSTANCE ON SURFACES, INCLUDING PATHWAYS AND COURTS.**
- **CHILDREN 12 YEARS AND UNDER MUST BE SUPERVISED AT ALL TIMES.** County Ord. 41.131
- **SURFACE MAY BE SLIPPERY. WATER SHOES ARE RECOMMENDED.**
- **BEACH BALLS ARE ALLOWED IN FOUNTAINS. NO OTHER TOYS ARE PERMITTED.**
