

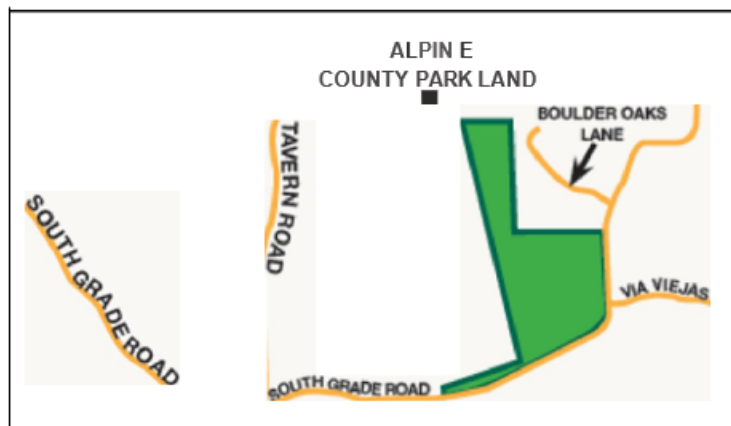
# NOTICE OF EXTENDED PUBLIC COMMENT PERIOD FOR THE RECIRCULATED PORTION OF THE DRAFT ENVIRONMENTAL IMPACT REPORT FOR THE ALPINE PARK PROJECT

NOTICE IS HEREBY GIVEN that the County of San Diego is extending the public review period for the Draft Recirculated Environmental Impact Report for the following project. **Alpine Park Project; SCH No. 2021030196.** On December 16<sup>th</sup>, 2022 a Notice of Availability was issued for the Draft Recirculated Environmental Impact Report for the proposed Alpine Park Project that set a 60-day public comment period that was to end on February 14<sup>th</sup>, 2023. The County has since replaced the *Preface*, *Executive Summary*, *Hazards and Hazardous Materials*, *Wildfire*, and *Alternatives* sections to correct minor typographical errors, including those with the strikeout/underline changes in the document, to provide clarity for the reader. No new information is presented in these replaced documents.

The County is extending the public comment period for the Draft Recirculated Environmental Impact Report by 14 days from the date of February 14<sup>th</sup>, 2023, for a total of 74 days. Comments on the Draft Recirculated Environmental Impact Report will now be accepted through **February 28<sup>th</sup>, 2023 until 5:00 P.M.** The Draft Recirculated Environmental Impact Report will continue to be available for review on the County's website at [www.sdparks.org/publicreview](http://www.sdparks.org/publicreview), at the County of San Diego, Department of Parks and Recreation, 5500 Overland Avenue, Suite 410, San Diego, CA 92123 and at the Alpine County Library, located at 1752 Alpine Boulevard, Alpine, CA 91901.
