- I. Meeting was called to order at 6:28 by Chair Rolland Slade.
- II. Kevin provided guidance regarding Brown Act changes for Remote Participation Disclosure.

- V. Park and Recreation Staff reports:
 - a. Sean update by Kevin:

 - ii. Calavo Park contract process will follow normal procurement process. Contractors interested in the skate park construction should see county site to be included in bidding. Since Calavo Park is funded from general county funds and not the CSA, information regarding the construction progress will need to come from the county.
