- Michael Hubbell:
- 40 ft cargo container project is moving forward to replace the existing sheds. It has gone out to bid. Should happen within a month or 2.
- New contractor walk-through for the well final meeting with him next week, end of February, and bid include new water tank.
- Off-leash area, which is in the T-ball field, will be closed to

dogs on March 1<sup>st</sup> to allow transition for the little league to play.

- Some of the limbs on the trees have been coming down. The ones that SDG&E have trimmed.
- The little league shed remains. Just the sheds that keep park equipment will be replaced with the cargo container.

## 7. Monthly Park Maintenance Fund Budget Update

- Mr. Hubbell presented the current Budget.
- Current budget is not sustainable. Income from Julian district property owners is less than the cost to maintain Jess Martin Park.
- Question was asked by Michael Charlonne if TOT funds are a funding option. Michael Hubbell will ask his boss.

## 8. Youth Advisory Update

- Mr. Hubbell stated that we, the committee, are responsible for bringing local youth to the next meeting on March 21st and asking them questions regarding the park's features.
- Joe Liggett mentioned that he would be able to bring 3 youths to the next meeting.
- Mike said he would bring at least one youth.

## 11. JMPAC Goals and Projects for 2023: Suggestions from Members

- Jim Schaible asked for more trees planted in the Park.
- Mike Hubbel said the county of San Diego has \$1,000,000 for the planting of trees. Mike Hubbel asked us to tell him what kind of trees and where we want them to be placed.
- Mike Charlonne asked for discontinuing the baseball fields for dogs. Recommended that board look to fund a dog park across hwy 79 on Old Cuyamaca road. It was pointed out that the only T-ball field only is to be used as an off-leash area from August 1<sup>st</sup> to March 1<sup>st</sup>, depending on if the little league makes the playoffs in July of each year.
- Baseball clinic with put on from professional baseball players. Mike Charlonne is planning on reaching out to Tony Gwynn Jr as dignitary for the 4<sup>th</sup> of July parade and then ask him about possibly putting on a clinic.
- Joe Liggett mentioned two local MLB players from Santa Ysabel who may be potentials, Cole & Beau Sulser.
- Carmen Longoria mentioned Santa Ysabel Tribal Youth sports.
- Joe Liggett recommended a baseball batting cage as a benefit for youth sports. The high school batting cage is in disrepair. The Jr. High batting cage is working.
- Carmen Longoria asked if the park has done any daffodil

planting at the parks. Carmen stated that their afterschool program has funding to pay for staff and a pool of children on what needs to be watered and when. Carmen will come up with some ideas and present them to the board.

- Drinking fountain in the middle broke last year and has been capped out. The one behind the dugout. Vandals have been stealing the fountain heads.
- Food truck during baseball games. Per Michael Hubbell, should be approved under baseball league use.
