Old Business - Park Updates

- Movies in the Park: Approximately 100 people attended the recent event, which included a music program prior to the movie. The next movie night is scheduled for August 23, with an anticipated turnout of 80–100 attendees.
- Sports Programs:
- A flag football league has expressed preliminary interest in using Jess Martin Park.
- The soccer league will begin at the end of September. Parks and Recreation is coordinating schedules for both soccer and flag football.
- AYSO has been unresponsive since the president relocated to Texas. Parks and Recreation will coordinate with Mike Charlonne for updates. Joe Ligget may be voted in as the new AYSO president. Both leagues plan to play games on Saturdays.

Monthly Park Maintenance Fund – Budget Update

- Current budget: \$32,322 as of July 31, 2025 (not including some staff costs and other expenses).
- The mower has been repaired. A backup mower is available at William Heise Park.
- Current local tax revenue is insufficient to cover all operating costs; Parks and Recreation continues to monitor the budget.

Wellhead Tank and Landscape Tie-In – Status Update

- Final budget approval is pending due to a contractor's earlier omission.
- Most state-required action items have been completed; the remaining items will be addressed once the contractor resumes work.
- No timeline has been set for restarting construction, though progress is expected by the next meeting.
